

## AEO Safety and Security Guidelines, Section I.2.5: Exporter

### **3.0.0 Physical Security**

#### **3.1.0 External Boundaries**

- 3.1.1 All buildings shall be constructed of materials which resist unlawful entry and protect against external intrusion.
- 3.1.2 All external and internal windows, gates and fences shall be secured with locking devices or alternative access monitoring or control measures such as internal/external anti-burglar alarm systems or CCTV (closed circuit TV systems).
- 3.2.0 Gates and Gateways**
- 3.2.1 All gates or gateways at the premises shall be identified.
- 3.2.2 When the gates or gateways are not locked, they shall be manned or guarded with alternative access monitoring or control measures.
- 3.3.0 Locking Devices**
- 3.3.1 Inner and outer doors, windows and gates shall be secured with locks.
- 3.3.2 Locks used to secure inner and outer doors, windows and gates shall be identified by type.
- 3.4.0 Lighting**
- 3.4.1 Where appropriate, adequate lighting shall be provided.

### **3.5.0 Access to Keys**

3.5.1 There shall exist documented procedures controlling access to the keys.

3.5.2 Only a limited number of persons shall be authorized to have access to the keys.

3.5.3 Keys shall be kept in a specially appointed place.

3.5.4 A person shall be held responsible for the keys.

3.5.5 There shall be a method of registering who is using the keys, when they were taken, by whom, and when they are brought back to the appointed place.

### **3.6.0 Internal Physical Security**

3.6.1 There shall be established internal physical security measures?

3.6.2 Only properly identified and authorized persons shall have access to internal sections of the premises.
